We're pleased to present to you our Annual Drinking Water Quality Report, also known as the Consumer Confidence Report. This report, a requirement of the 1996 amendments to the Safe Drinking Water Act, is designed to inform you about the quality water and services we deliver to you every day. Our constant goal is to provide you with a safe and dependable supply of drinking water. We want you to understand the efforts we make to continually improve the water treatment process and protect our water resources. We are committed to ensuring the quality of your water.

Water Source

Our water source consists of two bedrock groundwater wells located on the property referred to as Well #1 and Well #2. Well #1 is a six-inch diameter drilled well pumping approximately 35 gallons per minute and is 97 feet in depth. Well #2 is also a six-inch diameter drilled well pumping approximately 35 gallons per minute and is 450 feet in depth. Our system serves a population of 210 residents. Our certified lab was Phoenix Environmental Laboratories, Inc.

Due to lead and copper testing conducted in 2015, treatment will be required. In 2016, an engineer was retained to design a lead removal treatment system. Once designed, it was submitted to CT DPH for review and approval. Upon approval, the components were ordered and installed. We currently do not have any regularly scheduled meetings, however, if you have any questions about this report or concerning your water system, please contact Andrew Donnelly of White Water, Inc. at 253 B Worcester Road, Charlton, MA 01507 or at 774-633-1223. We want our valued customers to be informed about their water system.

White Water, Inc. provides the Moosup Garden Apartments with contract operation services. The contract operation includes the services of a state certified operator who monitors the water system for compliance with all state and federal drinking water regulations. The operating contract also includes services such as making emergency repairs when needed, making recommendations for improving water quality and increasing system reliability.

Source Water Protection

Source water is untreated water from streams, rivers, lakes, or underground aquifers that is used to supply public drinking water. Preventing drinking water contamination at the source makes good public health sense, good economic sense, and good environmental sense. You can be aware of the challenges of keeping drinking water safe and take an active role in protecting drinking water. There are lots of ways that you can get involved in drinking water protection activities to prevent the contamination of the ground water source. Dispose properly of household chemicals, help clean up the watershed that is the source of your community's water, attend public meetings to ensure that the community's need for safe drinking water is considered in making decisions about land use. A source water assessment report was recently completed by the Connecticut Department of Public Health, Drinking Water Division. The assessment found that this public drinking water source has **low to moderate** susceptibility to potential sources of contamination. Water Quality

Moosup Garden Apartments routinely monitors for contaminants in your drinking water according to Federal and State laws. The following table shows any detection resulting from our monitoring for the period of January 1 to December 31, 2016. It's important to remember that the presence of these contaminants does not necessarily pose a health risk.

The sources of drinking water include rivers, lakes, ponds and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and radioactive material and can pick up substances resulting from human or animal activity. All sources of drinking water are subject to potential contamination by substances that are naturally occurring or man made. Contaminants that may be present in source water include:

Microbial contaminants, such as viruses and bacteria, may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.

Inorganic contaminants, such as salts and metals, can be naturally occurring or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.

Pesticides and herbicides may come from a variety of sources such as agriculture, urban storm water runoff, and residential uses.

Organic chemical contaminants, including synthetic and volatile organic chemicals, are by-products of industrial processes and petroleum production, and can also come from gas stations, urban storm water runoff, and septic systems.

Radioactive contaminants can be naturally-occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, U.S. Environmental Protection Agency (EPA) prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. U.S. Food and Drug Administration (FDA) regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

The table below lists all of the drinking water contaminants that were detected through out water quality monitoring and testing. The presence of contaminants in the water does not necessarily indicate that the water poses a health risk.

Note: The state allows us to monitor for some contaminants less than once per year because the concentrations of these contaminants do not change frequently. Not all contaminants are tested for every year due to monitoring waivers and therefore we must use the most recent round of sampling. Some of our data is more than one year old, however, is limited to no older than 5 years.

Units:

Parts per million (ppm) or Milligrams per liter (mg/l) - one part per million corresponds to one minute in two years or a single penny in \$10,000.

Parts per billion (ppb) or Micrograms per liter - one part per billion corresponds to one minute in 2,000 years, or a single penny in \$10,000,000.

Picocuries per liter (pCi/L) - picocuries per liter is a measure of the radioactivity in water.

Micrograms per Liter (µg/l) – a measure of radioactivity in water.

Millirems per year (mrem/year) – a measure of radiation absorbed by the water.

Nephelometric Turbidity Unit (NTU) - nephelometric turbidity unit is a measure of the clarity of water. Turbidity in excess of 5 NTU is just noticeable to the average person.

Definitions:

Action Level (AL) - the concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

Treatment Technique (TT) - A treatment technique is a required process intended to reduce the level of a contaminant in drinking water.

Million Fibers per Liter (MFL) - million fibers per liter is a measure of the presence of asbestos fibers that are longer than 10 micrometers.

Maximum Contaminant Level (MCL) - The MCL is the highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

Maximum Contaminant Level Goal (MCLG) - The MCLG is the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

Drinking Water Equivalent Level (DWEL) – A lifetime exposure concentration protective of adverse, non-cancer health effects, that assumes all of the exposure to a contaminant is from a drinking water source.

Maximum Residual Disinfectant Level (MRDL) - The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

Maximum Residual Disinfectant Level Goal (MRDLG) - The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

Running Annual Average (RAA) - The average of all monthly or quarterly samples for the last year at all sample locations.

Non Detect (ND) - The contaminant was not detected.

IMPORTANT INFORMATION:

Arsenic: *The U.S. EPA adopted the new MCL standard of 10 ppb in October 2001. Water systems must meet this new standard by January 2006.*

Barium: *Some people who drink water containing barium in excess of the MCL over many years could experience an increase in their blood pressure.*

Copper - Major Sources in Drinking Water: *Corrosion of household plumbing systems; erosion of natural deposits; leaching from wood preservatives*

Health Effects Statement: *Copper is an essential nutrient, but some people who drink water containing copper in excess of the action level over a relatively short amount of time could experience gastrointestinal distress. Some people who drink water containing copper in excess of the action level over many years could, suffer liver or kidney damage. People with Wilson's Disease should consult their personal doctor.*

Lead - Major Sources in Drinking Water: *Corrosion of household plumbing systems; erosion of natural deposits.*

Health Effects Statement: *Infants and children who drink water containing lead in excess of the action level could experience delays in their physical or mental development. Children could show slight deficits in attention span and learning abilities.*

Adults who drink this water over many years could develop kidney problems or high blood pressure.

Nitrate: *Nitrate in drinking water at levels above 10 ppm is a health risk for infants of less than six months of age. High nitrate levels in drinking water can cause blue baby syndrome. Nitrate levels may rise quickly for short periods of time because of rainfall or agricultural activity. If you are caring for an infant you should ask advice from your health care provider.*

Total Coliform Bacteria - Reported as the highest monthly number of positive samples, for water systems that take < 40 samples per month. Coliforms are bacteria which are naturally present in the environment and are used as an indicator that other, potentially-harmful bacteria may be present. Our tests have all been negative.

Turbidity: Turbidity has no health effects. However, turbidity can interfere with disinfection and provide a medium for microbial growth. Turbidity may indicate the presence of disease-causing organisms. These organisms include bacteria, viruses, and parasites that can cause symptoms such as nausea, cramps, diarrhea, and associated headaches.

Water Quality Parameters Monitoring/Reporting Violation

During the monitoring period of January 1, 2015 to December 31, 2015, our water system failed to test and/or report water quality parameter results to the Connecticut Department of Public Health and therefore we cannot be sure of the quality of our drinking water during that time. Public notification was posted or distributed to all concerned residents on July 7, 2016. We will comply with the testing schedule in compliance with the Connecticut Department of Public Health's regulations. Since this violation, routine monitoring has resumed and results will be made available in the future.

Corrosion Control Treatment Technique Violation

During our January 1, 2015 to December 31, 2015 monitoring period, our water system exceeded the lead action level. Although this is not an emergency, as our customers, you have a right to know what happened. We routinely sample water at consumers' taps for lead. The tests show lead levels in the water were above the action level so we were required to investigate, propose and install corrosion control treatment to address the situation. We were supposed to submit a corrosion control treatment recommendation to the CT DPH by March 31, 2016 and failed to do so. Typically, lead and copper enters water supplies by leaching from pipes and plumbing components. New lead pipes and plumbing components contain lead are no longer allowed for this reason; however, many older homes may contain lead pipes. Your water is more likely to contain high lead levels if water pipes in or leading to your home are made of lead or contain lead solder. Newer homes with copper pipes may be more likely to have a problem with copper levels. This is not an immediate risk. If it had been, you would have been notified immediately. Since this violation, new water treatment was designed and installed for our system to address the lead issues. Routine monitoring has resumed and results will be made available in the future.

Lead & Copper Rule Exceedance

During our January 1, 2016 to December 31, 2016 monitoring period, our routine sampling detected Lead in excess of the maximum level allowed on multiple occasions. In January, 0 of 5 samples exceeded the Lead AL of 15.0ppb. In February, 3 of 12 samples exceeded the Lead AL; in November, 0 of 11 samples exceeded the Lead AL; in December, 6 of 20 samples exceeded the Lead AL. Drinking water regulations require that samples are taken from homes with a high risk potential for Lead in the plumbing. Public education material was distributed to all residents, shortly thereafter. However, if optimal corrosion control is not met after this effort to educate, we may propose to move forward with the installation of a passive neutralizer treatment system, consisting of one or two vessels with calcite media. Since this violation, routine monitoring has resumed on schedule and we are in full compliance with this order. Results of subsequent future Lead testing will be made available to all residents. **Lead Health Effects**: Infants and children who drink water containing Lead in excess of the action level could experience delays in their physical or mental development. Children could show slight deficits in attention span and learning abilities. Adults who drink this water over many years could develop kidney problems or high blood pressure.

All drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that the water poses a health risk. For most people, the health benefits of drinking plenty of water outweigh any possible health risk from these contaminants. However, some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and

infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. EPA/Center of Disease Control (CDC) guidelines on appropriate means to lessen the risk of infection by cryptosporidium and other microbiological contaminants are available from the Safe Drinking Water Hotline (800-426-4791).

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. We are responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for thirty (30) seconds to two (2) minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested.
